Notification

Whereas there has been manifold increase in vehicular traffic in Shimla Town.

And whereas with a view to reduce the pressure of traffic in the congested places in urban area of Shimla city, it is necessary to take remedial measures. Therefore, all heavy and medium goods vehicles coming beyond Dhalli i.e. from Upper Shimla and Naldehra side and other areas passing through Dhalli and are incoming towards Shoghi and beyond towards Kalka etc. shall pass through Dhalli via Bhattakuffar Mehli-Shoghi By-pass Road (except multi axel goods vehicles)

Now, therefore, in exercise of the powers vested in me under section 117 of the Motor Vehicles Act, 1988 and all other powers as mentioned above enabling me in this behalf, I, J.S.Rana, IAS, District Magistrate, Shimla, hereby order that heavy and medium goods vehicles coming beyond Dhalli i.e. from Theog and other areas passing through Dhalli shall take route of Dhalli via Bhattakuffar Mehli-Shoghi By-pass.

These orders shall come into force w.e.f. 8.10.2010.
